Findings from European study: UK survey

- **Lack of child care**
- **Young mothers do not wish to return to school**
- **Some schools are reluctant to re-integrate young mothers**
- **Peer pressure affects a young mother's return to school.**
- **Non-attendance at school has been associated with young mothers before their pregnancy**
- **Young mothers feel more grown up than their peers.**

What the government want

- Teenagers who become parents should not lose out on opportunities for the future. Young parents should have the chance to complete their education and prepare to support themselves and their family.
- 1. Better co-ordination so that pregnant teenagers get advice and support to stop them falling through the cracks;
- 2. under 16 year old mothers will be required to finish their full time education, and be given help with child care to ensure this happens.

Standards Fund Grant



- **Breaking down barriers to education including issues relating to childcare and transport,**
- **Working with educational establishments to change prevailing negative perceptions of pregnant young women and young mothers at an institutional level and develop quick and effective methods of referral,**
- **Successfully reintegrating and re-engaging pregnant young women and young mothers into mainstream and alternative education,**
- **Working with young women to capitalise on renewed motivation to succeed for the sake of their child.**

Problems with the current situation in England

- **LEAs: little known about the numbers, educational activities and/or needs of pregnant young women and young mothers.**
- **Many young women failed to receive home tuition:**
 - schools were unaware of correct procedure or
 - trying to conceal that there was a pregnancy at their school.
- **Schools not seeing it as their duty to make sure that pregnant young women and young mothers were comfortable at school,**
- **Schools not facilitating flexible or alternative provision to encourage their continued engagement.**
- **Lack of flexibility over schools uniforms**
- **Schools disallowing water in classrooms**

Problems with the current situation in England

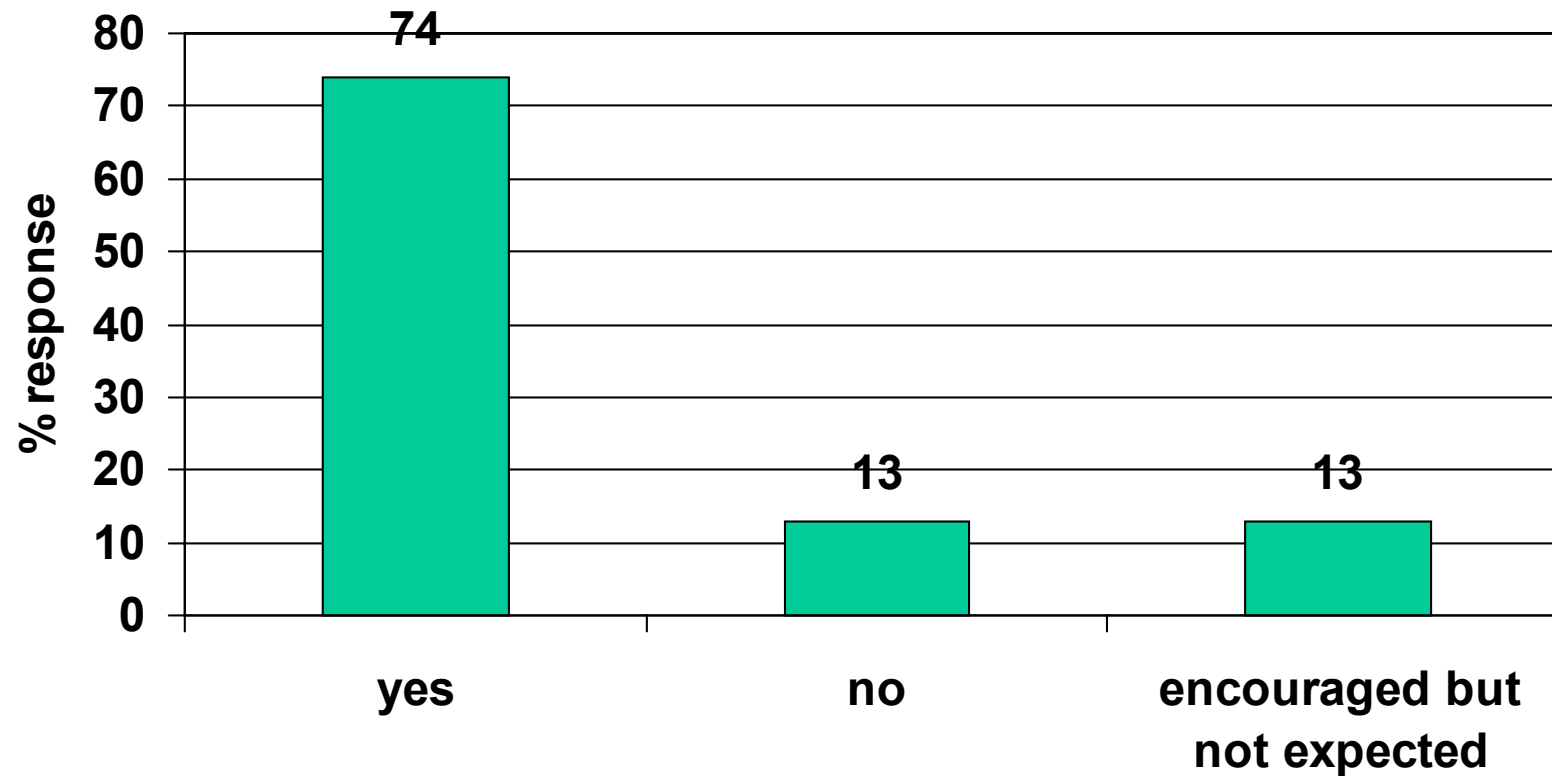
- **Evidence of bad practice in the following areas was found in a number of LEAs:**
 - Removing pregnant young women from school roles.
 - Incorrect attendance records at school
 - Forced maternity leave.
 - Admission refusals for Year 11 mothers who had missed a substantial amount of Year 10.
 - Pregnant young women and young mothers being made to feel unwelcome and hence choosing to leave of their own accord,
 - Pregnant young women being told, that on health and safety grounds, school was not the best place for them.



Factors related to engagement with education

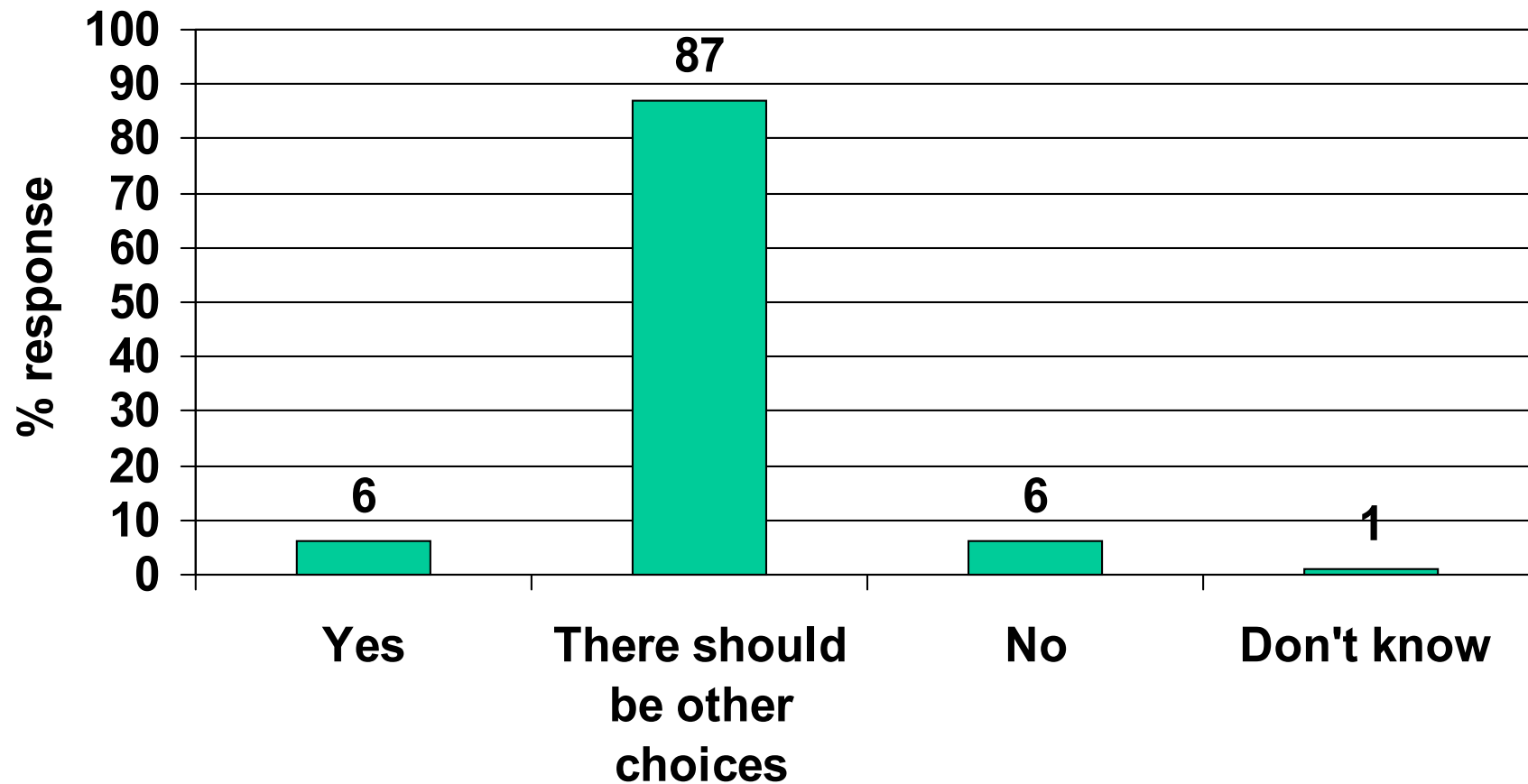
- 1. Enjoyment of school prior to pregnancy**
- 2. School attitudes to pregnancy and motherhood—
teachers and pupils**
- 3. Alternatives to mainstream school**
- 4. Levels of one-on-one support from a reintegration
officer (or equivalent)**
- 5. Levels of work support during maternity leave**
- 6. Family support (or lack of it)**
- 7. Childcare**
- 8. Being allowed to be a mum.**

Do you think young mothers should be expected to return to some form of education after birth?

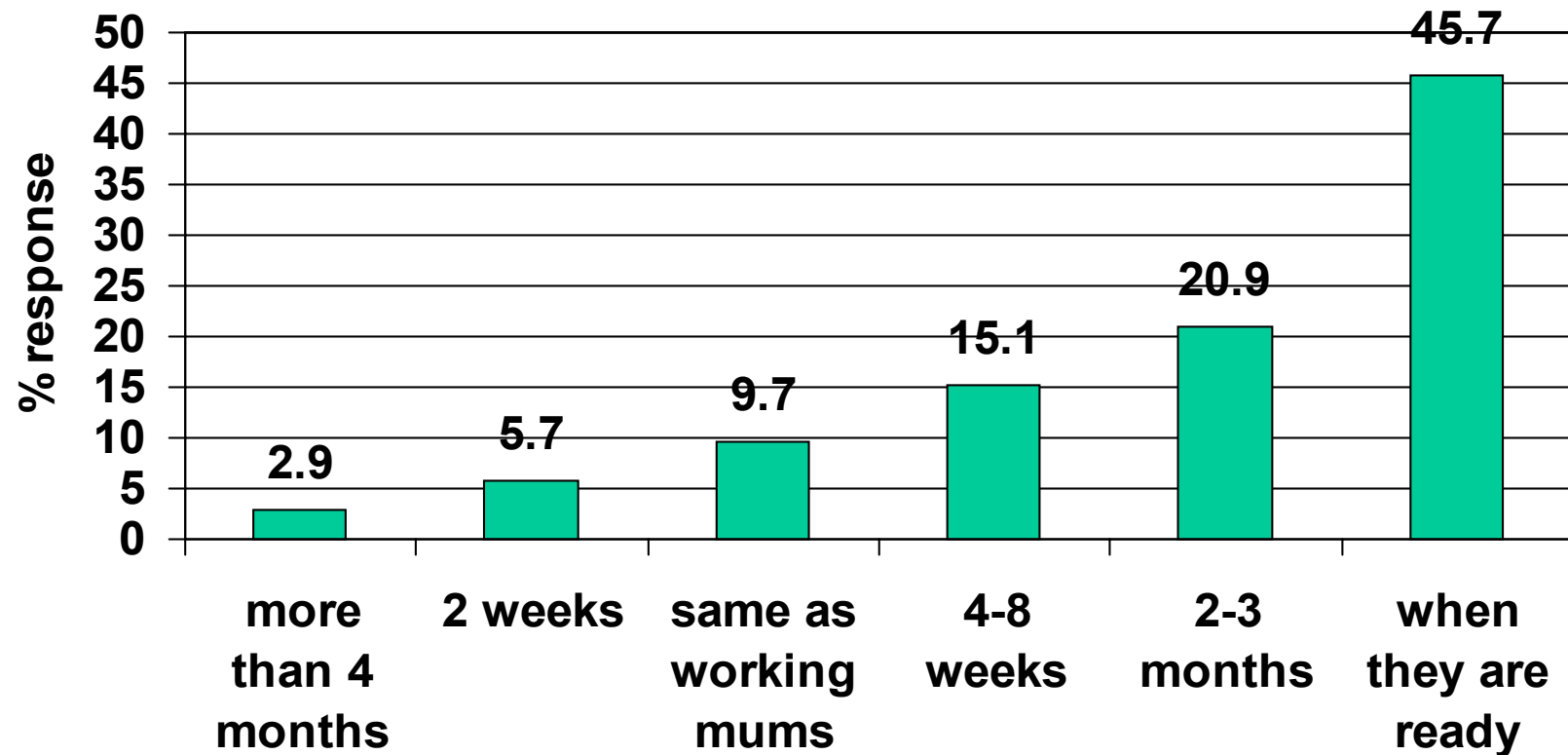




Do you think the government should encourage young mothers back to mainstream school after birth?

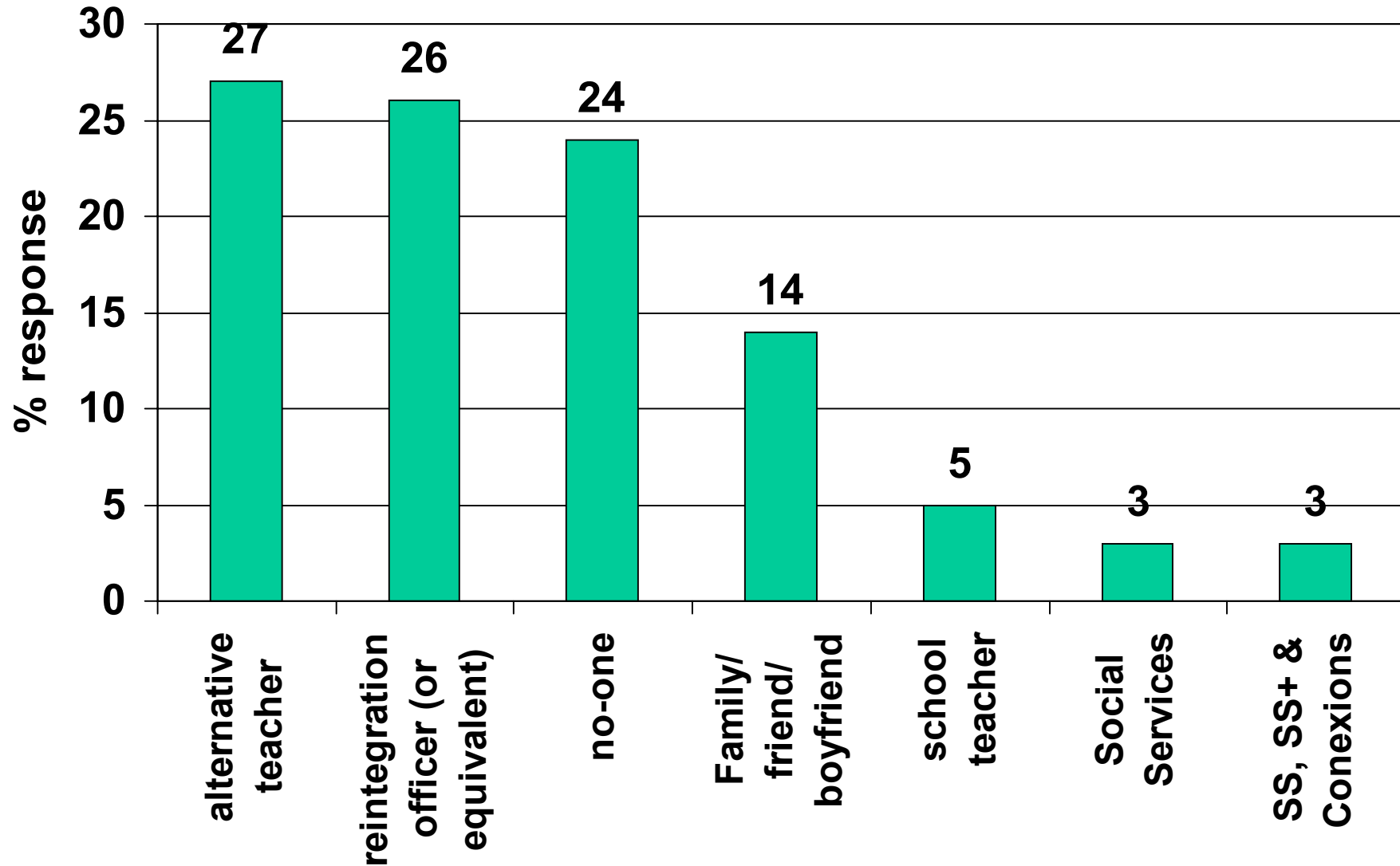

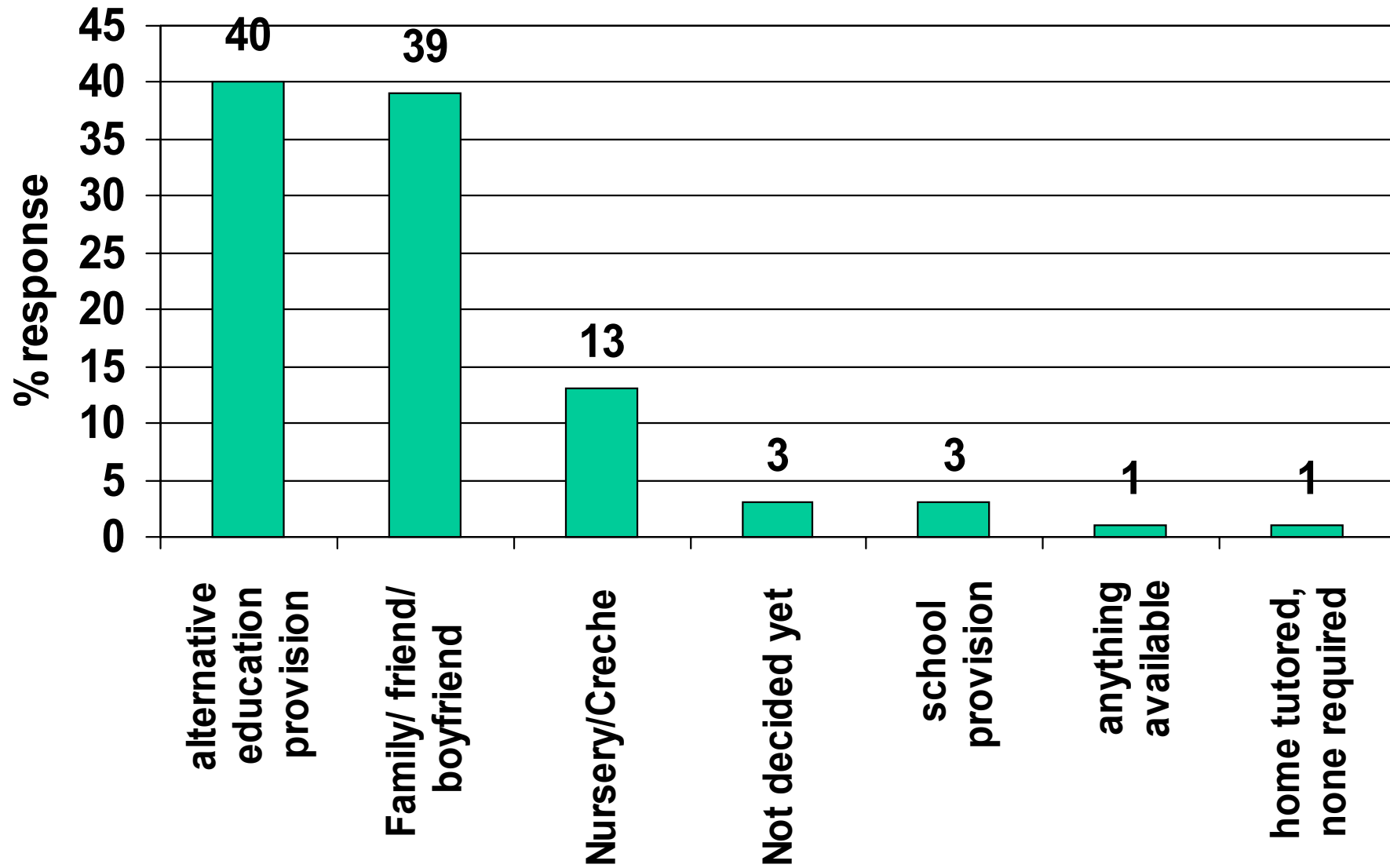

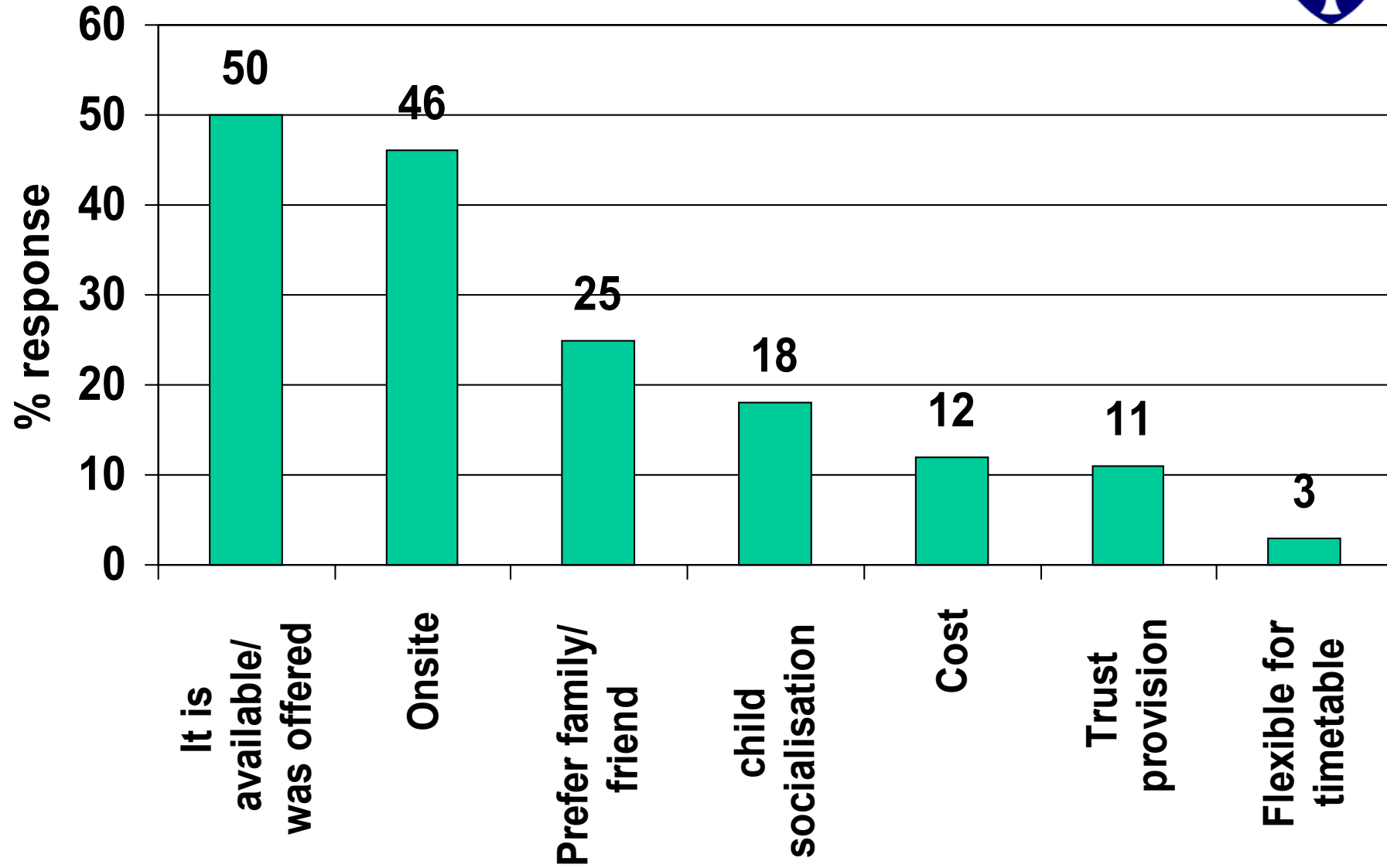

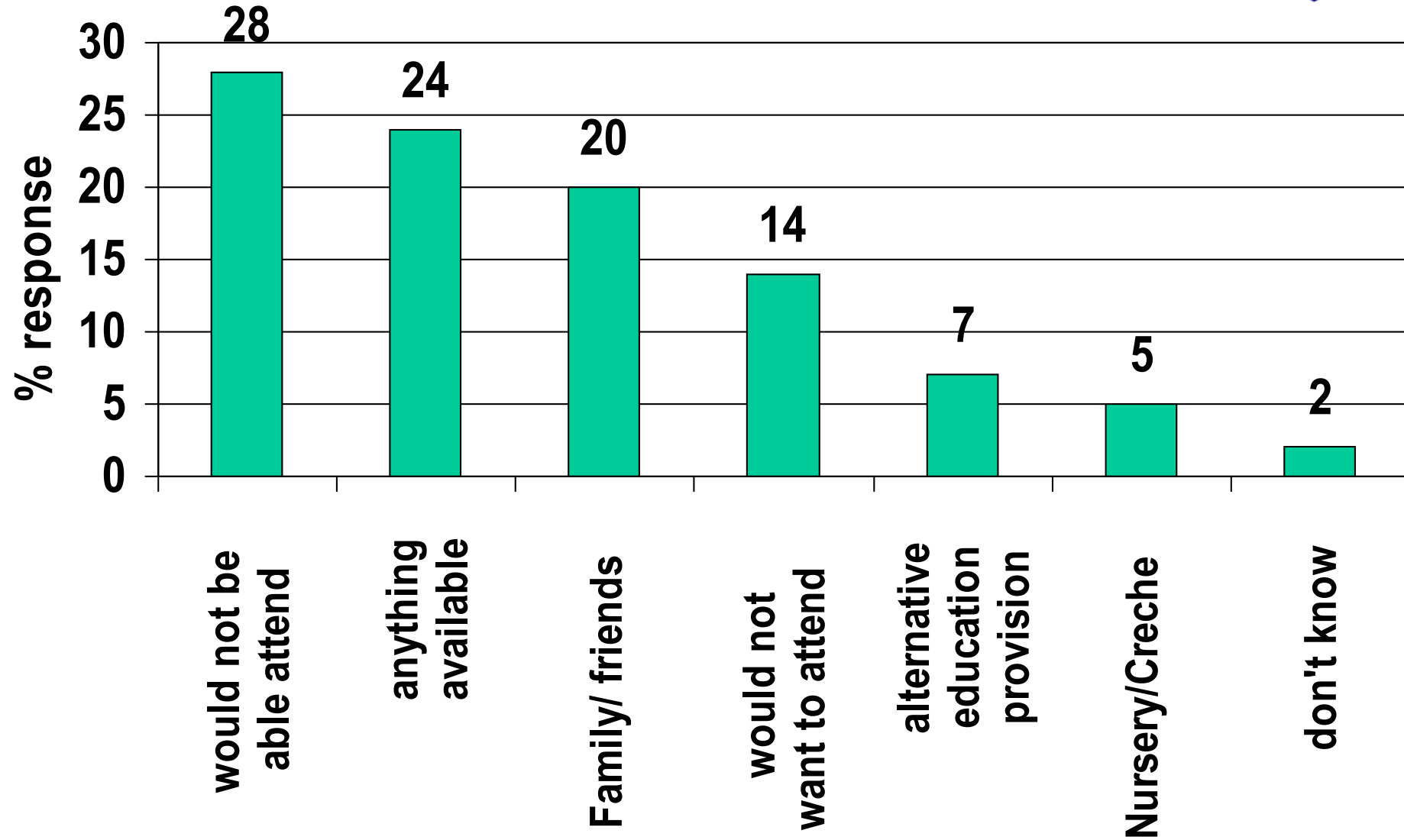
What childcare did you/ are you going to use?



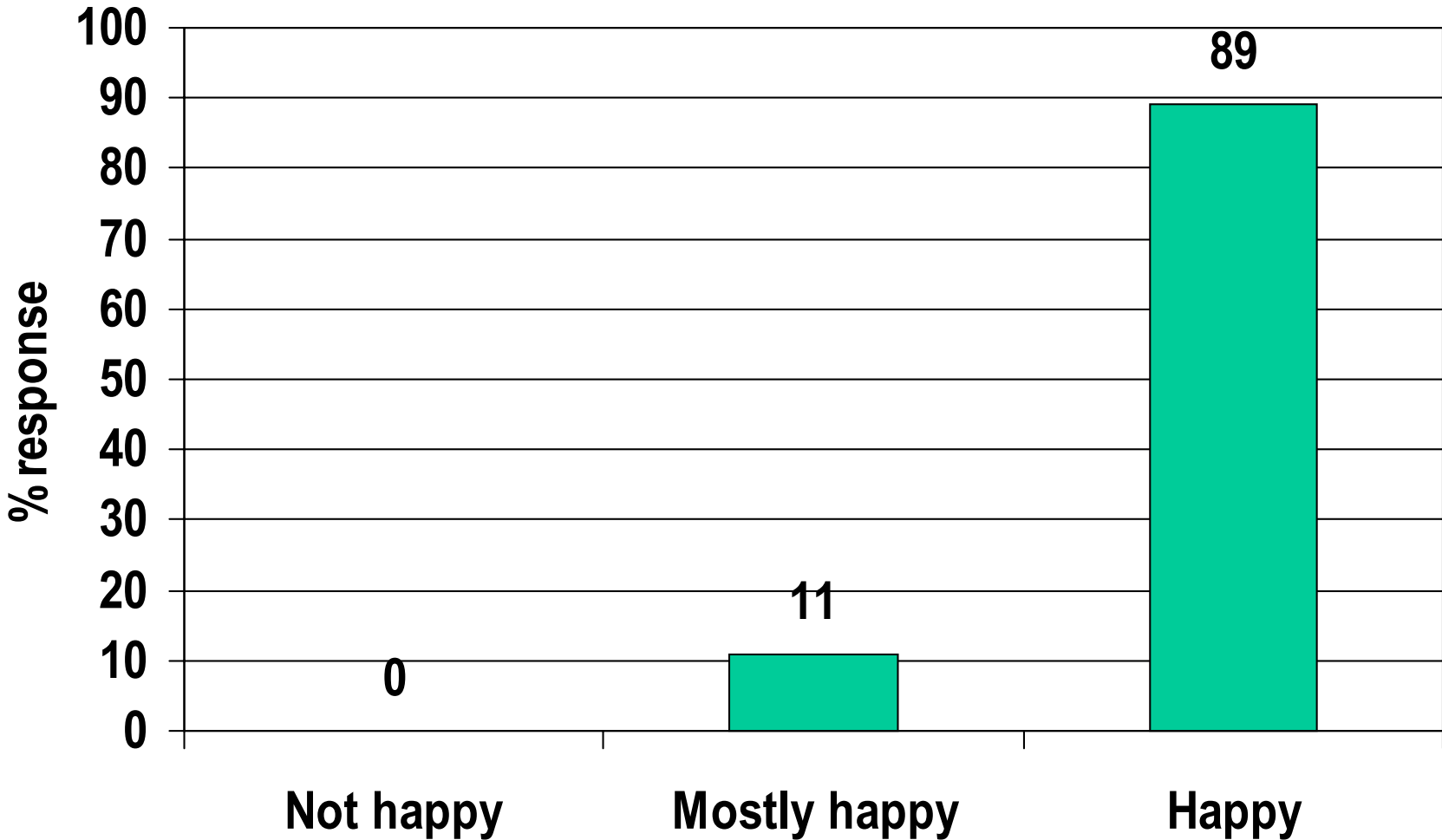
Why chose that childcare?
